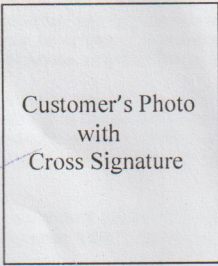

TERMS AND CONDITIONS

(A) CUSTOMER (as named in the front of this Agreement and hereinafter "Customer")'s OBLIGATIONS: Customer:

1. Understands that the Internet Telephony is governed by ISP and other applicable licenses and laws of the Indian Government (Department of Telecommunications). Customer shall therefore ensure compliance to such license conditions and laws and also ensure that Internet Telephony service (hereinafter "Service") provided by Arichwal IT Services Pvt. Ltd. (herein after "AITSPL") is not connected with PSTN (Public Switch Telephony Network). Any infringement would result in termination of Service without any notice. This will be in addition to any action taken by the Government, or under the Law.
2. Understands further that under no circumstances shall AITSPL, its affiliates or its contractors be liable for any direct, indirect, incidental, special, punitive or consequential damages that result in any way from Customer's use of or inability to use Service or any part thereof, or Customer's reliance on or use of information, services or merchandise provided on or through Service, or that results from mistakes, omission, interruption, errors, defects, delays in operations, or transmission, or any failure of performance.
3. Customer will pay to AITSPL for taking Service from them at the prescribed rate under different Plans, as described on the face of this form. Rates may be revised from time to time. Customer will be informed in writing, through any means of communication possible, in case the rates are revised. Details pertaining to Customer's account can be ascertained by him from the website www.aitSpl.in. Payment must be received by the due date to avoid suspension/ disconnection of the service. Non-receipt of the invoice by customer cannot be a reason for non-payment. Invoices/ account statements are posted on the website www.aitSpl.in and the customer can access the same by logging in the website.
4. Understands that the date of creation of Account is deemed to be the date of this Agreement.
5. Understands that it is the Customer's responsibility to get bandwidth connection from the nearest available source. The bandwidth should be sufficient (minimum 32-36 Kbps pure uplink) with low latency (less than 500ms to USA) to provide requisite quality call. The Customer Premises Equipment (hereinafter "CPE") needs real / private dynamic IP to work, which has to be provided by the Customer.
6. Understands that the Customer will make payment, for Service, in favor of Arichwal IT Services Pvt. Ltd, payable at Surajgarh. If the payment is made in cash, Customer must insist to have a proper/ valid receipt against cash payment and submit the same with AITSPL as and when requested by AITSPL. The Customer may make the payment also by purchasing vouchers available at AITSPL, Authorized Agents or websites.

(B) EXIT CLAUSE: This Agreement is valid unless terminated by AITSPL or Customer as per this clause and "Disconnection Terms" mentioned elsewhere in this Agreement. AITSPL or Customer can terminate this Agreement by giving one month notice. Customer is liable to pay service fee for one month, if he desires to terminate or terminates this Agreement without giving one month notice.

(C) DISCONNECTION TERMS

- a. AITSPL retains the right to terminate this Agreement immediately in case of Customer's default under clause 3 of „Customer's Obligations“.
- b. Termination by AITSPL can also be effected immediately under clause 1 of „Customer's Obligations“.
- c. Any loss of business suffered by the Customer due to disconnection affected under clause a & b in "Disconnection Terms" will be his own responsibility and so borne by him. Disconnection of Service under Disconnection Terms a & b will not require any notice and no refund will be given to the Customer for unused portion of Service.

(D) APPLICABLE LAWS

The laws of India shall govern this Agreement. The parties shall submit to the exclusive jurisdiction of Courts in Jhunjhunu. The Customer shall abide by all the applicable laws, rules and / or regulations and shall keep AITSPL indemnified against any damage, loss and claims arising out of its negligent acts or omissions. The Customer must indemnify AITSPL against any claims or legal proceedings arising from provision of Service, which are brought against AITSPL by anyone using Service under or through Customer because:

1. Service is used in breach of terms /conditions in this Agreement.
2. Service is faulty and cannot be used by a third Party.

(E) FORCE MAJEURE

AITSPL shall not be responsible or liable for any failure on its part to fulfill its obligations contained herein if such failure is on account of a force majeure event. Force Majeure shall mean such unforeseeable occurrences beyond the reasonable control of AITSPL such as:

1. Acts of God, natural catastrophes, frequency interference from external source, epidemics, earthquakes;
2. Strikes and blockades; either by AITSPL personnel or others affecting Service;
3. War or war-like conditions, mobilization, revolutions or riots, acts of public enemy, sabotage, terrorism;
4. Restriction by or actions, omissions or interventions of Indian public authorities (including but not limited to changes in laws, regulations or import / export, security restrictions).
5. Disconnection or deterioration of service by AITSPL's vendor.



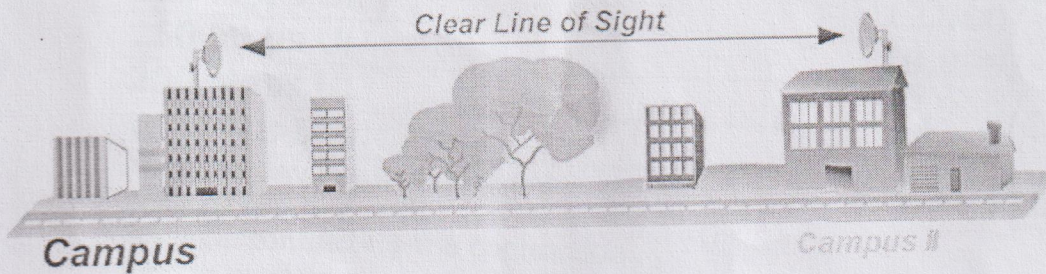

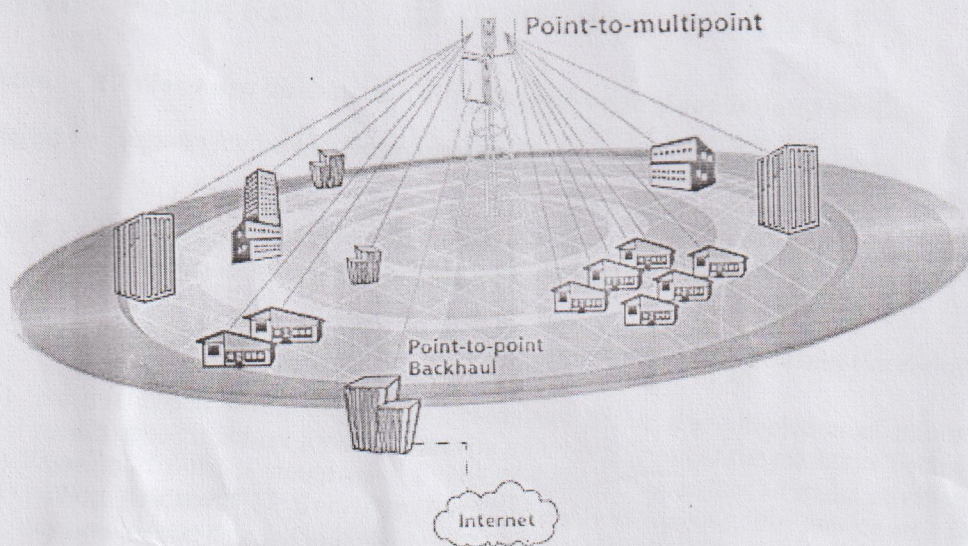

Terms and General Service Level Conditions for providing Internet the connectivity

- (1) No disconnection request will be entertained before the completion of minimum contractual tenure. One-month notice is a must for disconnection after completion of the minimum contractual tenure.
- (2) Payment of bills: It would be the responsibility of subscriber to make advance payment for Internet access service. **Arichwal IT Services Pvt. Ltd.** may disconnect the service in case of non-receipt of advance payment by due date without giving any notice to the subscriber.
- (3) The uptime of the bandwidth is 99 % assured.
- (4) **Arichwal IT Services Pvt. Ltd.** provide the latency speed of domestic is 8200 and international is 300-350 less than
- (5) The downtime caused due to BSO/Satellite Bandwidth Provider/International Bandwidth Provider/Abnormal Power conditions/Force Majors/any general law and order problems would not be our responsibility and the downtime caused due to the above cases will not contribute in the calculation of any downtime penalties whatsoever. However, we will work towards restoration of the services on utmost priority basis.
- (6) The Client will not utilize the bandwidth for any activity which is considered illegal by law, and shall not carry out any kind of direct or indirect Voice or any other prohibited traffic/signal/information and shall not be having any such interconnectivity of voice and voice-cum-data networks including PBXs/PABXs/PAXs on these circuits.

 - Any Hardware Failure.
 - Downtime due to backbone/International bandwidth provider.
 - Law and Order problems.

General Terms

- i) The validity of this offer is for a period of 15 days from the date of submission.
